The scale of subscriptions outlined below is for information only and no payment should be submitted with the application form.

1 Ordinary Members (Inport)	26 years of age and over (see note A)	£395.00
2 Ordinary Members (Midport)	26 years of age and over (see notes A & B)	£250.00
3 Ordinary Members	25 years of age and under	£50.00
4 Ordinary Members (Outport)	(see note B)	£35.00
5 Spouses of Members	Ladies and Gentlemen (see note C)	£78.50
6 Retired Members	(see note A)	
7 House Members	Including VAT	£120.00
8 Family Members	(See note G)	£520.00
9 Cadet Section	All ages 12 -18	£50.00

Notes

- A Inport and Midport Members having attained the age of 65 shall thereafter be liable only to the rate of subscription applicable to them in that year, to a minimum of 65% of the appropriate current rate.
- B Any Member with a boat moored at the club will pay the Inport rate.
- C Category 5 will only apply where one partner is an Ordinary Member.
- D Inport means residing within a radius of not more than 50 miles of the Clubhouse.
- E Midport means residing outwith a radius of 50 miles but not more than 250 miles of the Clubhouse.
- F Outport means residing outwith a radius of 250 miles of the Clubhouse.
- G Family Membership includes all children of Cadet age provided both parents are Members.
